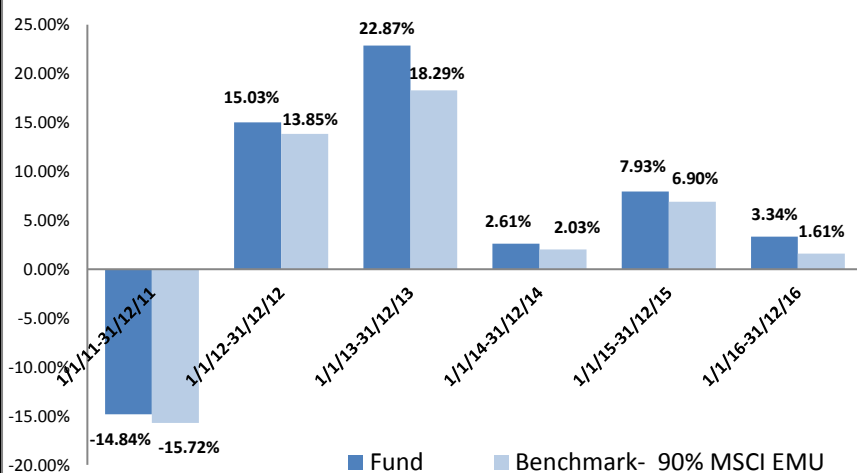

Objectives and Investment Policy								
<p>The investment objective of the Fund is to achieve long term capital appreciation. The Fund will invest primarily in equities of small, medium and large companies listed or traded on recognised European markets such as, but not exclusively, Austria, Belgium, Denmark, Finland, France, Germany, Greece, Ireland, Italy, the Netherlands, Norway, Portugal, Spain, Sweden, Switzerland, and the United Kingdom.</p> <p>Essential features of the product which a typical investor should know:</p> <ul style="list-style-type: none"> The Fund may also invest up to 20% of its net asset value ("NAV") of the Fund in bonds issued by commercial, governmental or supranational entities domiciled in EU Member States and denominated in a European currency. Investment in bonds may include investment in investment-grade or below investment-grade corporate or government bonds, which have a fixed or floating rate. The Fund may use financial derivative instruments, such as, but not limited to, futures, forwards, foreign exchange contracts (including spot and forward contracts) and options for efficient portfolio management or investment purposes. Shares in the Fund may be redeemed on demand, subject to certain restrictions, on each Dealing Day. The Company will reinvest any income that it earns from its investments. 	<p>Other Information:</p> <ul style="list-style-type: none"> The Fund may be leveraged as a result of its use of financial derivative instruments, but such leverage will not exceed 100% of NAV at any time. Investment in the Fund is suitable for investors who expect to maintain their investment over the medium to long term horizon.
